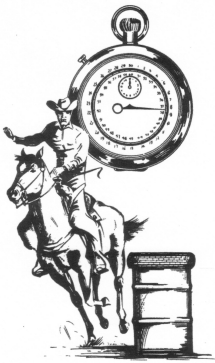

Complete Release and Waiver of Liability and Indemnity Agreement

“Inherent risks of equine activities” shall mean those dangers or conditions which are an integral part of equine activities, including, but not limited to:

- 1) The propensity of any equine to behave in ways that may result in injury, harm, or death to persons on or around them and/ or damage to property in their vicinity.
- 2) The unpredictability of an equine’s reaction to such things as sounds, sudden movements and unfamiliar objects, persons or other animals;
- 3) The equine’s response to certain hazards such as surface and subsurface objects;
- 4) Collisions with other equines, animals, people or objects;
- 5) The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or failing to act within his or her ability.

Neither the Edmonton Gymkhana Association and Member Clubs namely: Josephburg Riding Club, Paddle Valley Trail Riders and Gymkhana Club, Warden Riding Club (2011), Winterburn Riding Club, Woodlands Ste. Anne Gymkhana Club premises where any and all events are held the organizing committee of the show, officials, volunteers, staff nor agents shall in any way be liable for accident, injury, damage, loss or for any other grounds or to any animal or article brought to the grounds.

It is to be understood and agreed that by making any and all entries in the Edmonton Gymkhana Association and Member Club events all exhibitors, competitors, owners, agents and representatives acknowledge that equestrian sports involve inherent dangerous risk and do hereby indemnify and hold harmless the Edmonton Gymkhana Association and Member Clubs singular, the owners, or expenses, or any claim thereof of whatever nature arising or to arise for and on account, of by reason of participation in this show.
